LIFETIME RESIDENT MEMBERSHIPS

Initiation Fee for the first 15 successful applicants in the Resident category is \$17,500 + GST

RETIREE INCENTIVE

An Initiation Fee payment of \$10,000 + GST is available to persons 65 years of age or older.

- Three year payment plan is available.
- Upon application and acceptance the individual would be subject to the same dues and fees as a Resident member.
- Unrestricted golf is available until the Golfing Categories cap of 420 is reached. Thereafter, Waiting List privileges will apply.
- Membership application process according to the Club By-Laws is required. See details below.

TERM MEMBERSHIPS

5 Years of Golf for \$5,500!

- Initiation fee in the amount of \$5,500 + GST with a 5 year term of membership. After 5 years, the terms of the contract would be considered complete and any renewal would be subject to the policies as well as the market value at that time.
- Upon application and acceptance the individual would be subject to the same dues and fees as a Resident member. Privileges would be available to spouses of Term Members in accordance with the current structure for spouses of Resident members.
- There will be a limit of 10 Term Memberships per year.
- Unrestricted golf is available until the Golfing Categories cap of 420 is reached. Thereafter, Waiting List privileges will apply.
- Membership application process according to the Club By-Laws is required. See details below.

SOCIAL MEMBERSHIPS

With a one time Initiation Fee payment of \$1,500 + GST you will enjoy privileges in one of the area's premier dining facilities.

MEMBERSHIP APPLICATION PROCEDURE

1. All requests for membership must be commenced by an existing member of the Club who will serve as proposer for membership.
2. The proposer completes the letter of proposal and upon approval by the Membership Committee, an application is released to the proposer.
3. The applicant's name along with the proposer's name is posted in the clubhouse for 10 days as well as in the Club's monthly newsletter.
4. The proposer arranges for the completion of the application. The candidate will require a member of the Club to act as a seconder and 3 other Club members who will endorse the application. As well, the prospective member will be required to meet the Membership Committee whose Chairman and Co-Chairmen (or their designate from the Membership Committee) will also endorse the application.
5. A cheque or money order for the applicable initiation fee must accompany the completed application.
6. The completed application is returned to the Club for approval by the Membership Committee and the Board of Directors.
7. All members agree to be bound by all Club by-laws, rules and regulations.
